### **Engine**

Coverage includes pistons, piston rings, piston pins, crankshaft, main bearings, connecting rods, rod bearings, camshaft, camshaft bearings, timing chain, timing gears, intake valves, valve springs, oil pump, push rods, rocker arms, hydraulic lifters and rocker arm shafts. The cylinder heads and engine block are also covered if the above listed parts caused a Breakdown of the cylinder head or engine.

### **Water Pump**

Housing, bearings, impeller, hub and pulley.

### **Turbo/Supercharger**

Internally lubricated parts of the turbocharger/supercharger (factory installed only). The turbocharger/supercharger housing are also covered if the above-listed parts caused a Breakdown of the turbocharger housing or supercharger housing.

*\*\*Limit of Liability for Engine, Water Pump & Turbo/Supercharger is \$5000 for total of repairs.*

### **Transmission**

All internally lubricated parts of manual or automatic transmission, including oil pump, drums, planetary gears, sun gear and shell, shafts, bearings, side gears, carrier pinion gear, ring gear, shift rail, forks, synchronizers and torque converter. **Breakdown of the transmission/transaxle case if caused by the failure of an internally lubricated covered part.** Breakdowns resulting from failure by related parts or units such as, but not limited to: friction parts, such as clutches, CVT chain/belt, of any kind, levers, controls linkage, cables, radiator, coolers, rubber mounts, external oil lines, viscous couplings drive axles and electrical components, internal or external, to the engine and transmission are not covered.

### **Transfer Case**

All internally lubricated parts of the 4x4 transfer case including main shaft, counter shaft, internal gears, input and output shafts, bearings and spacers, shift forks, synchronizers and sleeves, springs and viscous coupling Breakdown of the transfer case if caused by the failure of an internally lubricated covered part. **Breakdowns resulting from failures by related parts or units such as, but not limited to: friction parts, such as clutches, of any kind, levers, controls, linkage, cables, radiator, coolers, rubber mounts, external oil lines, viscous couplings, drive axles and electrical components, internal or external, to the transfer case are not covered.**

*\*\*Limit of Liability for Transmission & Transfer Case is \$3000 for total of repairs.*

**Seals and Gaskets in Basic are only covered when required in connection with a covered Breakdown.**
